- Adjunct Faculty Pay
 - 1. The fulltime faculty would like to pus to get adjunct pay increased.
 - 2. Motion: Faculty Senate proposes that adjunct travel be reevaluated and more accurately compensated.
 - 3. We would like to see rankings and dollar amounts for adjunct pay at each level (adjunct with a bachelor's degree, master's degree, and doctorate) at each of the thirteen TBR community colleges.
 - 4. Suggestions included a longevity bonus for adjuncts who have taught more than *x* semesters, increasing to at least the overload pay for fulltime faculty, and possibly an appreciation dinner with an announcement of changes.
 - 5. More information and discussion to come.

VII. Vice President of Student Learning Update—Diane Ward

- A. SENSE Survey Data
 - 1. Highlights
 - a. "Instructors want me to succeed;" currently 4.32/5, up from 4.15 in 2015
 - b. "I have the motivation to do what it takes to succeed in college;" currently 4.42, up from 4.39
 - c. "A college staff member talked with me about my commitments outside of school to help me figure out how many courses to take;" currently 3.06, up from 2.73
 - 2. Three-Year Graduation Rates—up from 16.0% to 28.0%

 - 1. 360 applicants as of March 9, 2018
 - 2. Events planned to prepare Reconnect students AND for help with math and reading
 - 3. Technology Boot Camp in the works
 - 4. Adult Student orientation(s) will be held
