Admission Information Packet Roane State Community College- Occupational Therapy Assistant Program

The Occupational Therapy Assistant (OTA) is a health professional who uses purposeful activity to enhance daily functional abilities of individuals across the lifespan who may be limited by physical injury or illness, psychosocial dysfunction, developmental or learning disabilities, poverty, cultural differences, or the aging process. The OTA works under the supervision of an occupational therapist (OT) and collaborates with others to maximize independence, prevent disability, and maintain the health of individuals who require services. Students are educated in the skills and techniques necessary to participate in assessment and treatment in accordance with the occupational therapy plan of care and within state and federal regulations.

The OTA curriculum includes a blend of online and hybrid courses coupled with face-to-face labs. Students will need access to the Roane State Community College (RSCC) Learning Management System (Momentum) for asynchronous and synchronous coursework. Students will also need the ability to access Zoom. Students have the option to use RSCC Computer lab for these components of the OTA program. All students are required to travel to the Oak Ridge campus a minimum of one day per week for labs. Level I and Level II fieldwork experiences are completed through virtual and community-based practice settings. Placement decisions are based on factors such as site availability, alignment with program philosophy, and geographic proximity to the student.

NOTE: All OTA students must complete Level II Fieldwork within 18 months following completion of academic preparation.

Graduates of the program will be able to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification of Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). Initial certification is a requirement for licensure in all states.

NOTE: A felony conviction may affect a graduate's ability to sit for the NBCOT certification examination. A felony conviction may also affect fieldwork site placements.

Roane State Community College's OTA Program is accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 7501 Wisconsin Avenue, Suite 510E, Bethesda, MD 20814. Admission Requirements/Application Steps

The following items are all required for admission to the Occupational Therapy Program, but meeting these requirements does not guarantee admission:

- 1. Apply to Roane State, submit all required admissions documents (high school and college transcripts), and be accepted by the college.
- 2. Once accepted by the college, the student can then complete the Health Sciences application online through his/her RaiderNet account. Select "OTA" as the desired program of application.

Minimum academic requirements for Allied Health Science degree programs:

• Students under 21 years of age must attain a composite score of 20 or above on the ACT taken within the last 3 years OR attain a GPA of 2.50 or better after completion of at least 9 semester hours of general education courses required for the OTA program prior to the published application deadline.

- Students 21 years of age or older must attain a GPA of 2.50 or better after completion of 9
 hours of general education courses required for the OTA program prior to the published
 application deadline. These requirements are listed in the college catalog under the OTA
 program.

The deadline to apply for the OTA Program is March 31st. Applications received after the March 31st deadline will NOT be considered. The student must reapply every year they seek to be an applicant. Applications reopen during the Fall semester.

OTA program application requirement:

- 1. Observation Hours Form submitted by the application deadline:
 - a. There are two options to meet this requirement: **Do not do both options. You do either option 1 or 2. Note the videos are worth fewer points.**
 - i. **Option 1 (10pts)** complete 8 hours of OT observation. Observations may be either of in-person/face-to-face OT treatment OR observations of OT services delivered through telehealth technology.

- ii. **Option 2 (8 pts)**-Please review the following informational video approved by the American Occupational Therapy Association (AOTA) and the information page on the AOTA website.

Additional Information regarding progression and retention once in the OTA program

- Students must maintain a "C" in core OTA courses
 - Failure to meet the minimum grade required for any OTA course will result in dismissal from the OTA program. Courses must be completed in sequential order.
- Must pass the course competencies within each OTA course with a 75 or better
- Maintain an exam average of 75 or better
- Students must demonstrate safe and ethical clinical behavior
- Adhere to the OTA Policies
- Adhere to RSCC Academic Misconduct Policy
- Retention in the OTAP program is contingent upon meeting all conditions as outlined in course syllabi

Students who withdraw from one or more OTAP courses will be ineligible to progress to the next semester and/or term.

Failure to adhere to any of the above could result in dismissal from the RSCC OTA program.

*Students can reapply for admission to the program by following the readmission policy found in the OTA student handbook. Students will either remain dismissed or be allowed to reenter the program pending available space.
